

# Renewal of notification of recognised third party status

## Explanatory notes on completing form TP3

The notification of recognised third parties registered with The Electoral Commission will lapse 15 months after the original date of notification. Recognised third parties that wish to extend their notification beyond this point are required to submit a renewal notification to the Commission. This notification should be sent to the Commission within the period beginning one month before and ending three months after a recognised third party's original date of notification.

Recognised Gibraltar third parties can extend their notification in the same manner as any other recognised third party. They should however be aware that, with the exception of European Parliamentary elections, they are not subject to the same controls as other recognised third parties and are subject to lower expenditure limits. For further guidance please refer to *Guidance on registering as a recognised third party*.

**Important:** a recognised third party whose notification lapses during or at the end of a regulated period is still required to submit an expenditure and donation return to the Commission in relation to the election to which the regulated period relates.

Each note corresponds to a numbered section on form TP3.

### 1 Details of recognised third party

### 2 Declaration and signatures

Please delete the declaration as applicable to indicate whether the original notification remains the same, or whether any registered details have changed. If any details have changed, the amended details should be given at sections 3 and 4.

This notification must be signed and dated:

- in the case of an individual, by that individual;
- in the case of a registered party, by the leader and nominating officer (and, by an additional officer of the party if the same person is leader and nominating officer);
- in all other cases, by the body's secretary or a person who acts in a similar capacity (the position held should also be stated).

### 3 Change to original notification

Please specify which, if any, of the following details is or are to be amended:

- registered name;
- registered address;
- name of responsible person (this does not apply to individual recognised third parties);
- address of responsible person.
