## Summary

Under the Political Parties, Elections and Referendums Act 2000 (PPERA) there are rules on spending and fundraising that political parties have to follow in the run-up to elections.

Different elections have different spending limits, and these limits can apply for different periods of time. These rules were changed at the end of January 2014.

This document provides an overview for political parties of the regulated periods and when they apply for elections taking place in 2014-15.

## About our guidance

Each year, we publish specific guidance for political parties for the elections taking place in that year. These documents cover:

- The spending limits that apply for each election
- The periods that these limits apply for
- The reporting deadlines for each election

When preparing to contest an election, you should read both the specific guidance for the election you are contesting, as well as the general guidance documents on topics that apply to all elections.

## What is the regulated period?

In the run up to some elections, there is a set time where campaign spending limits and rules apply. We call this time the regulated period.

Regulated periods apply at elections to:

- The European Parliament
- The UK Parliament
- The Scottish Parliament
- The National Assembly for Wales
- The Northern Ireland Assembly

UK Parliamentary General Elections usually have a regulated period of 365 days ending on the day of the election but there will be a slightly shorter period for the UK Parliamentary General Election in 2015 (see page 6 for details).

All of the other elections usually have a regulated period of 4 months.

Spending at local authority elections is only covered by party campaign spending rules if it falls within the regulated period of one of the elections in the list.

## Elections in 2014-15

## **European Parliamentary Elections**

The European Parliamentary Elections are taking place on 22 May 2014. The regulated period begins on 23 January 2014 and ends on 22 May 2014.

## Local government elections in England

Local government elections are also taking place on 22 May 2014 in some parts of England.

These elections are being held on the last day of the regulated period for the European Parliamentary elections. The rules mean that all party spending on local government elections during the regulated period will be counted against the campaign expenditure spending limit for the European Parliamentary elections.

Any spending which can be attributed to promoting the electoral success of a specific candidate rather than the party does not count as party campaign spending.

## Referendum on independence for Scotland

The referendum on independence for Scotland will be held on 18 September 2014. The regulated period begins on 30 May 2014, and ends on 18 September 2014.

Spending on campaigning at referendums is regulated separately from campaigning at elections.

If your party intends to spend more than £10,000 on campaigning at the referendum, you will need to register with us as a referendum campaigner.

The rules on referendum spending are different from those for elections, and you should read our guidance carefully to decide whether or not you need to register with us.

## **UK Parliamentary General Election**

The UK Parliamentary General Election takes place on 7 May 2015. The regulated period begins on 23 May 2014, and ends on 7 May 2015.

## Changes to the combined regulated period

The 'regulated period' is the time during which spending limits and rules apply in the run up to an election.

The Transparency of Lobbying, Non-Party Campaigning and Trade Union Administration Act 2014 changed the combined regulated period for registered political parties contesting the European Parliamentary Elections being held on 22 May 2014 and the UK Parliamentary General election due to be held on 7<sup>th</sup> May 2015.

#### The position now

The Act means that the regulated periods and the spending limits are **not** combined for these two elections. The regulated period for the European Parliamentary Elections started on 23<sup>rd</sup> January 2014 and will end on 22 May 2014. The regulated period for the UK Parliamentary general election starts on 23<sup>rd</sup> May 2014 and will end on 7 May 2015.

### The position **before** the Act came into force

The regulated period for the European Parliamentary elections in 2014 began on 23 January 2014. If your party is planning on contesting both the European Parliamentary elections and the UK Parliamentary general election on 7 May 2015, there would have been a combined regulated period. This would have begun on 23 January 2014 and would have ended on 7 May 2015, and different rules and spending limits would have applied.

## The spending limit

#### The position now

There is no combined spending limit. Each election has its own spending limit. If you spend less than the limit for the European Parliamentary elections, you cannot carry forward the balance on the UK Parliamentary election.

#### The position **before** the Act came into force

There was a combined spending limit for the European Parliamentary election and the UK Parliamentary General Election. This meant that the spending limit for the European Parliament elections applied to that election. If you spent less than the limit for the European Parliamentary elections, you could have spent the balance on the UK Parliamentary election in the corresponding part of Great Britain or Northern Ireland. The total spending by or on behalf of your party on both campaigns could not exceed the combined limit.
