

Donations and loans received by political parties and non-party campaigners in the fourth pre-poll report at the General Election

Under the Political Parties Elections Referendums Act 2000, registered political parties must complete four weekly donation and loan reports prior to polling day on May 7 setting out what donations and loans they have received over £7,500 between 30 March (the start of the 'short' campaign) and 26 April. Two further reports follow after polling day for the period for the period 27 April to 7 May.

In addition, under the "Lobbying Act", registered non-party campaigners must also submit weekly donation reports setting out what donations they have received over £7,500. This information will be published alongside the political parties' donations and loans reports.

Second and third pre-General Election donations report by registered 'non-party campaigners'

Changes introduced by the Transparency of Lobbying, Non Party Campaigning and Trade Union Administration Act 2014, mean registered non-party campaigners – individuals or organisations that campaign at elections, but are not standing as candidates or political parties – must report before the election any donations that they have received that are over £7,500 and details of who has given them funding.
