

# Referendum on the UK Parliamentary voting system: Campaigner update on Royal Assent

---

The Parliamentary Voting Systems and Constituencies Bill received Royal Assent on 16 February 2011.

This means that the rules on campaigning at this referendum are now confirmed.

In particular, the referendum period began on 16 February, and will end when polls close on 5 May.

During this period, campaigners' spending and finance is regulated.

You must register with us if you want to spend more than £10,000 on campaigning in the referendum period.

## The designation timetable

If you want to apply to be the lead campaign group for either 'Yes' or 'No' at this referendum, we must receive your completed application by the end of Tuesday 15 March.

Under PPERA, we must make a decision on designating lead campaign groups by the end of Tuesday 29 March. We will make the decision sooner if we are able to.
