The Commission aims to respond to requests for information promptly and regrets that on this occasion we have not done so. Due to unforeseen delays in our internal processes we are unable to provide you with a response to your first request. However we have answered questions two to five, and we seek to provide you with the response to question one by Friday 17 March.

Your request is in bold below followed by our response.

You have requested:

- 1. Please supply all notes and emails connected with this application.
- 2. Please supply timetable for this application progress.
- 3. Please supply an explanation of the criteria for benchmarking the assessment of this application.
- 4. Please explain given the commitment to transparency of the Electoral Commission an official refuses to divulge this information without a struggle.
- 5. Why was the Electoral Commission Chief Executive collaborating with the Met police and the Crown Prosecution Service recently at the Inquiry of the London Assembly Police Committee especially as the later organisations are suspected of obstructing the law in relation to vote rigging?

Our response is as follows:

2. Please supply timetable for this application progress.

When assessing an application to register a political party, the Commission will take such time as it needs to gather any necessary information and be satisfied it is taking the right decision. The Commission took a decision in relation to this application on 23 February 2017.

3. Please supply an explanation of the criteria for benchmarking the assessment of this application.

The rules in relation to the registration of political parties are set out in the Political Parties, Elections and Referendums Act 2000 ('PPERA'). Particularly relevant to registration is Part II and Schedule 4 of PPERA.

In order to become registered, in accordance with PPERA, a party must have:

- made a complete application including the appropriate declarations, which is accompanied by a copy of the party's constitution and a draft financial scheme;
- adopted a financial scheme;
- proposed to register a name which does not contravene any of the tests set out at paragraph 28(4) of PPERA. In summary those tests mean that the Commission determines not to register a party with a name that it considers:
 - o is likely to mislead voters as to the effect of their vote;
 - o is the same as another registered identity mark which is on the same register;
 - is the same as an identity mark from a deregistered party which was on the same register and is protected until the end of that party's financial year in the year they were deregistered;
 - is likely to result in voters confusing it with another party identity mark that is already registered or protected;
 - o is likely to contradict or hinder instructions or guidance given for voting;
 - o is obscene or offensive;
 - o contains certain prohibited words;
 - o is longer than six words;
 - o is not in Roman script;
 - o is likely to amount to an offence if published.

There are also rules in relation to what descriptions and emblems a party may register, however, they do not effect whether or not a party can be registered.

Claire Bassett, the Chief Executive of the Electoral Commission was invited to attend the London Assembly Police and Crime Committee meeting on 9 February 2017 by the Chair of the Committee, Steve O'Connell AM. Ms Bassett was present to explain the role of the Electoral Commission in relation to tackling electoral fraud.

Our response is as follows:

We responded to request number 2-5 above separately on 14 March 2017. This response only addresses request 1 above.

In relation to request number 1, we attach a set of documents. These are the notes and emails that the Commission holds up to the date of your request, 13 February 2017, in relation to the consideration of an application to register a political party 'Tower Hamlets Together (THT)'.

Copies of these documents are attached.

Some of the information contained in these documents contains personal data which is exempt from disclosure under Section 40 of the FOI Act. These documents have been redacted prior to release. Further explanation of the exemption is provided below.

Section 40(2) and (3)(a)(i) of the FOI Act

Section 40(2) provides for an exemption where the information requested constitutes personal data as defined by the Data Protection Act 2000 (DPA), and where release of the information requested would breach one of the data protection principles.

Some of the information contained in the requested information falls within the description of personal data as defined by section 1 of the DPA because the information relates directly to an identifiable living individual.

Some of the redactions we have made relate to direct contact information of staff members and the names and contact details of junior staff members. Other personal data has been withheld as it relates to sensitive personal data of individuals. Disclosure of both types of personal data would contravene the first principle of the DPA.

The first data protection principle states that personal data shall be processed fairly and lawfully. The Commission considers that it would be unfair to release the information requested as it would be reasonably expected by those individuals

Due to the large number of attachments for this response, we have employed the use of our secure cloud-based document storage system 'Objective Connect'. You will receive a 'Invitation to **Objective Connect** Email Notification' (sent to the inbox of notification will contain a link to enable you to start using **Objective Connect**. 

Thank you for your letter of 2 February about the Electoral Commission's consideration of an application to register a political party named Tower Hamlets Together. The view that democratic participation needs to be accompanied by strong checks and balances is one that we share and take very seriously.

The Commission considers all registration applications carefully in line with the Political Parties, Elections and Referendums Act 2000 ('PPERA'). In assessing the application to register Tower Hamlets Together, we will apply the statutory party registration tests in PPERA, ensuring we treat all applicants fairly.

We are of course fully aware of the history of Tower Hamlets First and the strong public interest in the registration of political parties in this particular borough. I can assure you that we will undertake a robust assessment of all applications accordingly. As part of our assessment of the application of Tower Hamlets Together, we will want to be sure that the party have and operate within a satisfactory constitution, and adopt and operate within a satisfactory financial scheme.

While the Commission must only apply the rules set out in PPERA in relation to the registration of a political party, we have taken steps to enable the transparency of the party registration process. For example, all complete applications that are submitted to the Commission are placed on our website and members of the public or political parties are invited to submit their views on the application. These are taken into account before the Commission makes any final decision on an application to register.

At our meeting on 1 February you indicated that you would welcome further advice on how the system for registering political parties can be improved. The Commission has previously urged government to consider reviewing this part of PPERA. For example:


- At present, there is no transparency about, or controls over, the sources of money for new parties before they register. Financial information is only provided in a party's first statutory Statement of Accounts, which, depending on when they register, may not be submitted for publication for up to 18 months after registration. In our 2013 review of the UK's party and election finance laws, we made recommendations that would improve transparency and provide voters with more timely information about the financial capacity of newly registered parties. These include requiring parties to report on their total assets and liabilities as part of the registration process and to confirm the accuracy of their financial scheme on an annual basis. A change to the law as outlined above would ensure that any individuals who wish to apply to register a political party know that right from the outset their finances will be subject to detailed scrutiny.
- In May 2014 we wrote to Greg Clark MP, the then Minister for Cities and Constitution requesting consideration of changes in the rules on party registration, in that instance specifically and urgently on the rules on party descriptions to address voters being confused or misled by the current use of party descriptions on ballot papers. That could be achieved by requiring that all ballot papers should show the registered name of the political party to which a candidate belongs, as currently at most elections there is no requirement for the party identity to be clear to voters or removing the facility to use party descriptions altogether on ballot papers, so that only the party name appears. This change could be accompanied by new provisions to allow larger parties to indicate via their party name their country specific identities, as exists within the Scottish election rules, e.g. Scottish Conservatives; Welsh Labour.

You enquire whether the involvement of a particular individual behind an application for registration of a new political party should be grounds for refusal. That is not presently the case. Apart from the restriction at s.24(8) PPERA that you identify on holding office as a Treasurer if convicted of an electoral offence, there are no other applicable provisions in PPERA of this nature. This is another area where a review of the PPERA



provisions to see if the law should be improved could be considered. That might include prohibiting a person disqualified from holding elected office being able to be an officer of a registered political party.

We would welcome the opportunity to discuss with your officials how and when these changes could be implemented by legislative change.

Electoral Commission's consideration of political party registration in the London Borough of Tower Hamlets

In April 2015, an Election Court disqualified the then Mayor of Tower Hamlets, Lutfur Rahman, for a series of corrupt and illegal electoral practices. He was disqualified from any public office for five years under Section 160 of the Representation of the People Act 1983.

Part of the judgment highlighted a series of concerns related to the registration, financial administration, and declarations of his political party, Tower Hamlets First. Following the disqualification of the Mayor, this subsequently led to the de-registration of the political party by the Electoral Commission. The remaining Tower Hamlets First councillors, originally elected under the Mayor's ticket, have continued as (fragmented) independent groups on the council.

It has now been reported that Lutfur Rahman is launching a new political party, entitled, "Tower Hamlets Together" ahead of the 2018 Tower Hamlets Council and Mayoral elections, and that this new party has submitted an application to the Electoral Commission.²

When registering, a political party must submit to the Electoral Commission a financial scheme (procedures for handling loans and donations, authorising spending and accounting) and a constitution (outlining the party's governance, structure and rules).

In light of: (a) the electoral fraud proven previously in the Election Court; (b) the Government's stated intention to tackle electoral fraud robustly; (c) this Borough remaining a high risk area as identified by the Electoral Commission; and (d) Government-appointed Commissioners continuing to oversee the London Borough of Tower Hamlets, I believe there is a strong public interest in the Electoral Commission forensically reviewing any application.

This should include establishing whether proper processes are in place for complying with the legal obligations under the Political Parties Elections and Referendums Act 2000, both at

registration and moving forward, especially given such a new political party would appear to be a re-branded version of the previously de-registered party.

In addition, I would be grateful if you could indicate whether you feel it appropriate that an individual currently under a Section 160 disqualification for electoral offences should be involved with the registration of a political party. One may wish to consider the broader provisions of Section 24(8) of PPERA which may be guiding when considering a political party registration, and the fact that Section 160 also disqualifies the individual from being a registered elector and consequently from being a permissible donor under PPERA. When the Electoral Commission considers whether there is a necessary level of assurance in the financial scheme and constitution of a party, I would suggest that assurance is unlikely to be provided by the involvement of such individuals.

As the Government's recent response to Sir Eric Pickles' review of electoral fraud noted, we need to ensure democratic participation goes hand in hand with checks and balances to strengthen electoral integrity.

I look forward to your response.
