The data collection form – which includes the statutory statement as to postal ballots as well as requests for addional data – can also be found under the <u>resources section of Part F of our guidance for Returning Officers</u>.

The <u>guidance note</u> provides information on what should be returned. The two forms are on different tabs of the data collection form (Form R - Statement as to postal ballot papers and Additional Data form). We require both Form R and the additional data at a local authority level.
