#### "Pooled" Election Expenses - Receipts for Payment

At a meeting of prospective General Election candidates in Scotland for the Trade Unionist and Socialist Coalition on 8th March 2010, it was agreed that in order to minimise costs, certain expenditure would be better centralised and I, Gordon Morgan, was appointed agent to manage that expenditure on the candidates behalf. TUSC eventually stood in 10 Scottish seats and the "pooled" expenditure covered

- a) the printing of an election leaflet
- b) the delivery of the leaflet to the post office
- c) the production of a Party Political Broadcast and its delivery to the BBC and STV
- d) production of a banner and hire of rooms for a public launch rally and press conference.

I can confirm that in total the amount of "pooled" expenditure came to £8,515.85 for the ten constituencies and that all invoices relating to this expenditure were paid by 27th April. As proof I attach copies of 6 receipts amounting to £7,340 and can attest that I can account for all other amounts.

A total of £1,861.71 was received from Solidarity: Scotland's Socialist Movement towards this expenditure, which has also been reported under individual constituency returns. I have analysed the expenditure in line with Electoral Commission guidelines and the expenditure across categories of the monies received from Solidarity is as follows:


