As a Director at RH, Nigel developed the Group's freight transport, commercial vehicle and truck rental operations. In 2011 the company was sold to the Swiss international logistics firm Kuehne and Nagel.

In 2012 Nigel led a team and re-acquired part of the RH Group, RH Commercial Vehicles (RHCV), from Kuehne and Nagel. He is now Managing Director of RHCV which is an authorised Renault Trucks distributor, specialising in sales, parts and servicing for heavy and light commercial vehicles from its head office in Nottingham, plus sites in Leicester and Alfreton (Derbyshire). Employing a team of 69 in total, Nigel is also Managing Director of RH Development (Property) Ltd – a specialist property development and angel investment business.

Nigel is also an experienced arable farmer and currently farms 800 acres / 323ha in rural Nottinghamshire.

Carl Chambers (Chairman)

Carl Chambers has lived and worked in Leeds for 16 years. After qualifying and practicing as both a barrister and chartered accountant, he worked in private equity and corporate finance for 10 years with 3i, NatWest Markets, HSBC and Coutts. In 1996 he was one of the

founding directors of Spice plc, a Leeds based company. As Chief Financial Officer and Corporate Development Director, he helped grow the company from a start-up to a FTSE business with turnover of nearly £400 million employing c.4,000 people. In recent years he has been a non-executive director of several businesses. He is currently chairman of Harrogate based gas supply business CNG Ltd and a non-executive director of Leeds Teaching Hospitals NHS Trust where he chairs the Finance and Performance Committee.

Why I'm taking part in the debate: Although I am in my 50s, I have never had a say on the UK's membership of the EU. My parents did and they voted for membership having been led, wrongly, to believe they were voting for membership of a trading bloc, a Common Market. The reality is that the EU is moving inexorably towards political union and a federalist state. There are many reasons why I believe that, in the absence of fundamental change, the UK must leave the EU but the loss of sovereignty inherent in that move to political union is by far the most important to me. I believe that laws affecting UK citizens should be initiated and enacted by a UK parliament, not by a body where we are underrepresented and where much of the power lies in unelected and unaccountable hands. That is why I am trying to play an active role in the imminent debate. This is a truly once in a lifetime event which is likely to affect us for decades. If we stay, we will either wither on the fringes of a two-speed EU or be sucked into the large federal state the EU will become. If we leave I believe the UK will thrive outside the EU; but if I am wrong, at least the decision will have been ours, and the way in which we deal with it will be up to us.
