

Reporting on the administration of elections on 2 May 2019

This note outlines the Commission's requirements for the return of **data** and **feedback** for the Local Government, City Mayoral and Combined Authority Mayoral elections in England on 2 May 2019.

This includes what must be returned, where to find the forms to be returned and where to return completed forms. It also sets out requests for feedback on the experience of administering the elections.

Instructions for returning data

1. The Commission will **collect all forms directly**. Please return all forms by e-mail to research@electoralcommission.org.uk.
2. Please return all forms **no earlier than Tuesday 28 May** (25 days after the poll) and **no later than Thursday 6 June 2019**. Please ensure that you make arrangements for the data to be returned, particularly if the person responsible for them will be away when the returns are due.
