UK Parliamentary general election: electoral register to be used for nominations

We have received a number of queries relating to which electoral register should be used for the nominations process.

As we highlighted in our [supplementary guidance note](#) to support (A)ROs and EROs with the management of the forthcoming UKPGE, to be valid, subscribers will need to be included on the register that is in force on the last date for publication of the notice of election (i.e. on 11 November).

If you have already published your revised register by that point, this will be the register in force. If not, it will be your last published notice of alteration, including any additional monthly notices of alteration published in October and/or November.

You should ensure that candidates and their agents are aware of which register to use when completing their nomination papers

UK Parliamentary general election: expediting postal ballot packs to overseas and BFPO addresses

In the absence of any changes to the legal framework for the management of overseas postal votes, we recognise the practical challenges you face in ensuring that overseas voters who choose to vote by post receive their postal vote in time to complete and return it before the close of poll.

However, as you will be aware, to help address this known issue for the UK Parliamentary general election, Cabinet Office have provided information on a facility that the Royal Mail and the British Forces Post Office (BFPO) are providing to help expedite the despatch of postal ballot packs to overseas addresses and BFPO addresses.

To support you in ensuring you are able to make use of the service, please find below a reminder of the process to follow, along with contact information should you have any further questions.

Postal ballot packs to overseas addresses via Royal Mail

Cabinet Office have advised that ROs should work with their print suppliers to ensure that standard overseas ballot packs for each individual parliamentary constituency (not including those to be sent via BFPO) are separated from the usual despatch of postal ballot packs and instead sent via Royal Mail's 9am Special Delivery service to:

Ballot packs should be bundled by constituency and in country order where possible. All bundles should include [a header sheet](#) that details the following information:

- Date of despatch
- Local authority
- Parliamentary constituency
- Volume of items

Postal ballot packs via British Forces Post Office

As above, ROs should work with their print suppliers to separate postal ballot packs to be sent via BFPO addresses from the rest of the despatch and send via Royal Mail Special Delivery to:

UK Parliamentary general election: update on party names, descriptions and emblems

As set out in [Bulletin 253](#), updates are still being made to the online register of political parties. While we do not intend to make further updates to the register after 12 November 2019, there is the potential that we may need to do so, and we will highlight in a future Bulletin any additional changes that are made after this point.

Since Bulletin 253, we have made updates to the following on the register of political parties:

When receiving nominations, (Acting) Returning Officers must check that the party name or any description given on a nomination form, as well as the requested emblem, is registered on the Commission's [register of political parties](#) and that the details provided match the registration. To ensure you are viewing the most up-to-date information, you may need to delete your browser history or refresh the page. If you are unsure how to do this, your IT team should be able to advise you.

Emblem Zip file

A Zip file of emblem images is available on our website and was last updated on 7 November. You should not use any Zip files downloaded before this date for any purpose.

While the Zip file can be used by your printer to prepare ballot papers, it is the information on the Commission's [register of political parties](#) that should be used for confirming which emblem and description to print on the ballot papers. **You should therefore ensure that you and your printers only download and use the Zip file once nominations have closed.**

UK Parliamentary general election: cyber security advice

As was the case in advance of the 2017 UKPGE, the National Cyber Security Centre (NCSC) has again published guidance to support administrators, political parties and those who want to participate in the electoral process which includes important information around good cyber security practices for the systems that support the delivery of UK elections.

Where possible, please share the guidance for individuals with candidates and agents in your area.

In addition to the points covered by the guidance for ROs, there are a number of further practical steps you should take which will help you mitigate risks to the process:

- You should perform regular (at least daily) back-ups of register databases to ensure you have an accessible and secure electronic copy of the registers you will need for the election
- You should produce hard copies of the polling station registers as early as possible, and ensure that these are checked for accuracy in advance of use on polling day

The NCSC has also provided specific guidance to political parties on the risks from phishing, but [this guidance](#) is equally helpful for ROs.

UK Parliamentary general election: public awareness update - voter information resources

When our campaign launches, we'll use TV and online video to reach mass audiences, supported by social media advertising to target specific under-registered groups. We'll also share this content via our social media channels, and intend to boost the reach of our campaign through PR and partner activity.

Reach British citizens overseas

Our campaign to encourage UK citizens living overseas to register to vote has now launched.

We've created [resources that you can share](#) to raise awareness amongst people living overseas. These include images for Facebook, Twitter and Instagram, along with suggested social media posts and a template blog.

Our messaging directs people to gov.uk/register to vote. The registration website advises them about voting by proxy (including postal proxy) and postal voting.

Your vote is yours alone

Help prevent electoral fraud by sharing our '[Your vote is yours alone](#)' resources.

The campaign, which we are delivering in partnership with the charity Crimestoppers, highlights what constitutes electoral fraud.

It aims to empower people to protect their vote, and to report any concerns to Crimestoppers anonymously. Bilingual resources are available which include videos, online and offline posters,, and social media posts and graphics.

Helping electors understand the registration process

We will be updating the information available on the voter section of our website to try to address any confusion that may arise from the two-stage registration process, in particular the potential for individuals who have added their name to a HEF during the canvass to think they are already registered without having completed a registration application.

You should also consider how the messaging you include with ITRs makes clear the need to complete a separate application as part of the registration process, even where they have recently responded to a HEF, as well as highlighting the registration and absent vote application deadlines.
