## UK Parliamentary general election: thank you

Following the UK general election last week, the focus is on politics and the results and not on the process of running the poll. This is exactly as it should be, reflecting that the election was generally well-run.

And this didn't happen by accident - we are only in this position as a result of the significant efforts and intense work of electoral administrators across the UK. It is to the credit of (Acting) Returning Officers, Electoral Registration Officers and their teams that the poll was delivered successfully at short notice.

However, we all know about the pressures on electoral administrators in running a general election within the current framework, and we know that there were instances where electors did not receive the standard of service we would all want them to.

We are now focussed on collecting feedback and data to inform our post-election reporting. We will use this opportunity to fully review the election and consider any recommendations - whether for us, governments or the electoral community - that could improve the process in the future.

As highlighted in [recent Bulletins](#), we'd like to hear your views and experiences of administering the UK Parliamentary general election and are also collecting administrative data relating to the poll via an online portal.

## Data collection

We will be sending out emails tomorrow (18 December) inviting you to register for the online data portal. As set out in [Bulletin 257](#), this email will be sent from [research@electoralcommission.org.uk](mailto:research@electoralcommission.org.uk) to your generic local authority elections email address. To register, click on the link in the email, where you will be asked to set up a password.

Once registered, you can access the portal using the log-in page – a link to that page will be provided when you register. It can also be found on [our website](#) and in the [user guide](#). You can then enter your electoral data. The deadline for submission of data is **Friday 17 January 2020**.

The user guide includes the list of the generic local authority election email addresses we have used to contact you. If you do not receive an email, please [contact us](#) to let us know what generic local authority elections email address we should use.

## Electoral registration: 2019 canvass data collection

As in previous years, we will be collecting data relating to the annual canvass and the publication of the revised registers. As highlighted in [Bulletin 257](#), the deadline for submitting your data will be **Friday 24 January 2020**.

As usual, the data to be provided is contained in reports which can be generated via your EMS system. If you're experiencing technical issues, the fastest way to resolve these will be to contact your EMS supplier directly for support.

We will be collating and publishing the information that we receive so we ask that you please check your data after you generate the automated report and before you submit it to us in order to help ensure its accuracy.

Once you have generated the report in your EMS system and reviewed the data, please submit it to [CanvassData@electoralcommission.org.uk](mailto:CanvassData@electoralcommission.org.uk) before Friday 24 January 2020. Please note that this email address is different from that we've used in previous years.
