May 2021 polls: publication of supplementary planning guidance

Further to our update in [Bulletin 279](#), we have now published [the first in our planned series of supplementary guidance](#) to support administrators with preparing for and delivering the May 2021 polls against the backdrop of the coronavirus pandemic.

This document, which was developed with the expert advice of Public Health England, Scotland and Wales, and in consultation with the Elections, Referendums and Registration Working Group (ERRWG), Wales Electoral Practitioners Working Group (WEPWG) the AEA, Welsh and Scottish Governments, and Cabinet Office has been designed to support you with the decisions you will need to take to manage the particular challenges related to the current public health situation.

The guidance covers areas such as the importance of risk assessments, the identification and booking of suitable venues, and addressing the challenges relating to staffing requirements. This guidance will remain a living document which we will update as needed in light of any changes to legislation or public health advice that arise following publication. We are aware that the Welsh Government's Elections Planning Group is still working on plans for 2021 and we will update this guidance as needed to reflect this once work of the group is completed.

This supplementary guidance is the first of a series, with further resources to follow covering the key parts of the electoral process such as the management of nominations and absent voting arrangements, as well as the conduct of polling day and the verification and count. We are continuing our focussed work with public health bodies and stakeholders from across the electoral community to develop the detail of these additional guidance resources, which we'll publish on a rolling basis over the coming months.

2020 canvass: update

Publication of the revised register

Further to [Bulletin 274](#), the UK Government [has now passed legislation](#) to extend the deadline for Electoral Registration Officers (EROs) in Great Britain to publish their revised registers after the 2020 canvass, from Tuesday 1 December 2020 to Monday 1 February 2021. This legislation applies only to UK Parliamentary registers in Wales.

Similar legislation relating to the local government register [passed in the Senedd](#) on 29 September.

As you will be aware, monthly notices of alteration to the register must be published on the first working day of each month, apart from in the month you are publishing the revised register and in the two months prior. However, while you are not required to publish monthly notices of alteration in the two months prior to the publication of your revised register, you may decide to publish monthly updates during this period.

In order to be able to publish your revised register later than 1 December, you would therefore need to have published notices of alteration in October and, possibly, November. You should plan for publishing monthly notices of alteration in October and November if you wish to give yourself the flexibility of publishing after 1 December and this will enable you to revisit your publication plans as needed as the canvass progresses.

If you do decide to publish an update in October and/or November, you should ensure that those who are entitled to receive the register are aware of your plans and are able to receive the updates.
