May 2021 elections: public attitudes towards voting in England and Wales in the context of COVID-19

In December 2020, the Commission undertook research in England and Wales to better understand attitudes to voting in the context of COVID-19. This research follows two such surveys carried out in August and November 2020 with [voters in Scotland](#).

The [research](#) shows that a majority of voters in both England and Wales would feel safe voting in person at a polling station, with appropriate hygiene measures and physical distancing in place. However, the research also indicates a likely increase in postal voting at the elections in May 2021.

These findings reflect attitudes at the time of fieldwork. While they are helpful in highlighting the potential impact of COVID-19 on resourcing and processes for delivery of the 2021 elections, they should be treated as an indicative snapshot of views, rather than a predictor of voter behaviour. Also, the views expressed may be weakly held and subject to change depending on the wider context since this work was carried out.

May 2021 elections: FAQs for local authorities

Preparations continue for the Senedd and PCC elections in Wales and more widely across Great Britain for the polls scheduled to take place in May. Since the New Year, and given the developments in the public health situation, there has been speculation in the media and elsewhere about whether the polls will go ahead in May.

We are liaising with the UK's governments and with the electoral community on these issues. In the meantime, to assist local authorities with communicating the current situation to the media and voters, we have developed some FAQs, which you can find below. We have also shared, for your information, our current press line.

We recommend the lines below should only be used reactively, to answer any questions from journalists or members of the public. The information below is accurate as of Tuesday 19 January, however this is an evolving situation. We will share any further information, as needed, via Roll Call and the Bulletin.

Current Electoral Commission statement

"It is an important democratic principle that elections should proceed as scheduled whenever possible. To ensure they can do so this May, we continue to work with the electoral community, informed by the latest public health advice.

"Voters should be able to participate in the polls, campaigners and parties be able to put their case to the electorate, and electoral administration staff be able to run the polling stations and count centres, safely and confidently.

"As preparations for the polls continue, we are working closely with the electoral community to provide support, and to understand the impacts of the pandemic on their complex and important work. We will be communicating with voters to ensure they understand how to participate in the polls safely."

FAQs

Are the elections on 6 May being postponed?

The elections are scheduled to go ahead as planned on 6 May. We are working hard to ensure that they can proceed effectively, including that polling stations will be safe places to vote.

Who makes the decision to postpone the elections?

Any decision to postpone the Senedd election would be for the Senedd. The Welsh Government is currently preparing a bill which would enable the elections to be postponed by up to six months, if necessary. Any decision to postpone the Police and Crime Commissioner election would be for the UK Government to make, and be subject to parliamentary approval.

Do you think they can go ahead in the current circumstances?

electoral administrators, to ensure the elections can be delivered safely and successfully.

We are working with the UK's governments, the Electoral Commission, the wider electoral community and public health authorities to ensure that voters can cast their votes safely at the elections on 6 May 2021.

These preparations allow for a range of restriction levels in May.

We are also putting arrangements in place to help ensure polling stations are safe places to vote. Voters can expect many of the measures they've become used to over recent months, such as the use of hand sanitiser, floor markings and face coverings.
