May 2021 elections: post-election feedback and data collection

The final counts have now been completed and the results are all in for the May 2021 elections. This was one of the most complex sets of polls held in recent times, with the additional and far-ranging challenges presented by the COVID pandemic. We know how challenging it has been to plan and deliver elections in this context, but thanks to the hard work, careful planning and dedication of election teams across the country over many months, voters, campaigners and polling station staff were able to take part safely and confidently.

While a detailed process of information gathering and evaluation will follow, our initial assessment is that the polls were well-run. Current evidence indicates that they took place without significant or widespread administrative issues, making best use of new and adapted processes to support COVID-safety, and supporting the participation of the electorate in these important democratic events. This apparent smooth-running of the democratic process is a testament to the dedication and hard work of the electoral community.

We know the process was not without its difficulties, and we will work with you to explore the issues you faced and understand the impact they had on the elections as a whole.

We will be reporting formally on the delivery of the polls in the autumn, so that important lessons can be captured and learned. We hope that you and your colleagues will share your experience of delivering these elections to inform our reporting. Our regulatory work also begins now, to support parties and campaigners to comply with the campaign finance requirements that provide for public transparency.

Data collection

We will be sending out emails tomorrow (12 May) inviting you to fill in data through our online data portal. As set out in [Bulletin 309](#), this email will be sent from research@electoralcommission.org.uk to your generic local authority elections email address (in the majority of cases).

If you do not receive an email you can look at the [user guide](#) which at the end includes the list of the generic local authority election email addresses we have used to contact you. If you can see we have the wrong email address (or the right email address but you don't receive an email), please [contact us](#).

Most local authorities are already registered on the portal (from the 2019 UKPGE) so you can access it [here](#), although you will need to reset your password first.

If you are filling out data for local elections, we strongly recommend you read the user guide before starting to fill out any data.

The deadline for submission of data is Monday 21 June 2021. If you have any questions, please contact us at research@electoralcommission.org.uk.

May 2021 elections: polling station staff survey

May 2021 elections: forwarding of candidate spending returns to the Commission

The Commission will be collecting copies of candidate spending returns for the following elections:

- the London Mayoral election;
- the Greater London Authority elections;
- Police and Crime Commissioner elections; and
- Combined Authority Mayoral elections

For those elections only, could Returning Officers please provide to us:

- Electronic PDF copies of candidate spending returns, declarations and any accompanying invoices and/or receipts delivered to you after the relevant election, to candidates@electoralcommission.org.uk
- Notification of any candidates who have not submitted a spending return at the point you send PDF copies of the returns to us
- Any passwords you have used to lock the PDF files. These should be sent in a separate email

Combined Authority Returning Officers should also provide us with the electorate figure used for the purpose of calculating the candidate spending limit in your electoral area. This is the electorate figure on the last date for publication of the notice of election.

We will not require candidate spending returns for any other type of election than those listed above.

There is no statutory deadline for you to provide the returns to us, but we would be grateful if you could do so by no later than the following dates to enable us to publish key data from these returns:

- Combined Authority Mayoral elections and constituency candidates at the Greater London Authority elections: **2 July 2021**
- Police and Crime Commissioner elections, London Mayoral election, and London-wide candidates at the Greater London Authority elections: **6 August 2021**

Please do not send:

- Paper copies of the returns
- Originals of the returns: you must retain these for public inspection for two years after their receipt
