## May 2022 elections: update on party names, descriptions and emblems

As per our approach to providing updates on changes made to party names, descriptions and emblems set out in [Bulletin 316](#), we can confirm that since then, no updates have been made relating to parties who are registered to field candidates at elections in Wales.

**When receiving nominations, Returning Officers must check that the party name or any description given on a nomination form, as well as the requested emblem, is registered on [the Commission's register of political parties](#) and that the details provided match the registration.** To ensure that you are viewing the most up-to-date information, you may need to delete your browser history or refresh the page. If you are unsure how to do this, your IT team should be able to advise you.

## May 2022 elections: public awareness update

### Got 5 is live!

Our 'Got 5?' campaign is now live and will run up until midnight on 14 April – the registration deadline. Our channels include TV, video on demand (catch-up TV), radio, digital audio, digital display (website banners) and social media. This will also be supported by unpaid press, partnership and social media activity.

### Welcome to Your Vote is also live!

Our 'Welcome to Your Vote' campaign is now live and will run up until midnight on 14 April. We'll be reaching 16 and 17 year olds through Instagram and Snapchat advertising which will support partnerships, unpaid press and social media activity aimed at qualifying foreign nationals and 16 and 17 year olds.

### Digital transparency campaign

We are once again running our [digital transparency campaign](#) ahead of the May elections which aims to encourage people to think more carefully about the political campaign advertising they see online. We want people to be confident about understanding [digital political campaigning](#); understand who is targeting them and why; and know how to take action if they see something that concerns them.

The campaign will run from 25 March – 4 May on Facebook and Instagram and is aimed at 18 – 24 year olds.

- Voter information – key information about accessibility and how to find your polling station. We recommend that you distribute this press release in the final week before polling day (28 April – 5 May)
