May 2022 elections: update on party names, descriptions and emblems

As per our approach to providing updates on changes made to party names, descriptions and emblems set out in [Bulletin 316](#), below is a summary of the updates we have made since [Bulletin 318](#).

As you will see, there have been a number of recent changes to the register and whilst not all will be relevant to candidates standing in your area, it is important that you read the list of updates to parties carefully to ensure that you are aware of changes that may impact on those standing in your area:

No parties have been deregistered since the previous Bulletin.

When receiving nominations, Returning Officers must check that the party name or any description given on a nomination form, as well as the requested emblem, is registered on [the Commission's register of political parties](#) and that the details provided match the registration. To ensure that you are viewing the most up-to-date information, you may need to delete your browser history or refresh the page. If you are unsure how to do this, your IT team should be able to advise you.

May 2022 elections: post-election data collection

The Commission will be reporting on the May 2022 elections and, as ever, feedback and data from Returning Officers, Electoral Registration Officers and administrators will play a vital role in informing these reports.

We've summarised our plans below, along with some early information on how and when we will be asking for your help.

Post-election data collection

The data we are going to collect can be found [here](#). The file includes all elections that could take place in Wales, so please look at the appropriate column(s) for the election(s) you have in May 2022.

We will once again be collecting the data via our post-election data portal.

You will receive an email (sent to your generic local authority email address) soon after the elections explaining how to access the data portal so you can fill in the data at your convenience. Your previous passwords will have lapsed so you will need to reset the passwords on your account. The deadline for completing data will be Friday 10 June.

Polling station staff survey

We are carrying out a survey of polling station staff across the UK to collect feedback about their polling day experiences. The polling station handbook (hard copy and digital) will feature a QR code which staff can use a smart phone to scan to access the survey. The link to the survey will go live on the afternoon of polling day.

We would appreciate your help in highlighting the survey to your polling station staff, such as through your planned training. Alternatively, in the week after polling day we will provide you with a link to the online survey, which you could then e-mail to polling station staff.

Candidate survey

We are also carrying out a survey of candidates who stood for election in May 2022, asking about their experiences through from nominations to the count.

On 10 March we wrote to all ROs in Wales to ask for their help in sharing the survey with candidates where an email address is held for them.

The survey will be open from Friday 6 May and we would ideally like invites to go out as soon as possible after the election. We intend to make the survey link and accompanying explanatory text available by mid-April, so please look out for an email from the team in Wales about this in due course.

Dissolution and Calling of Parliament Act: update

The Dissolution and Calling of Parliament Act received Royal Assent on 24 March.

This repeals the Fixed-term Parliaments Act, re-establishing the pre-2011 process by which the Prime Minister requests a dissolution from the Sovereign which, if granted, would enable the Prime Minister to call a general election at a time of their choosing. The next UK Parliamentary general election (UKPGE) is no longer scheduled to take place in May 2024, but must now be held by 28 January 2025.

All references to the process for calling a general election in our core UKPGE guidance have been updated accordingly.
