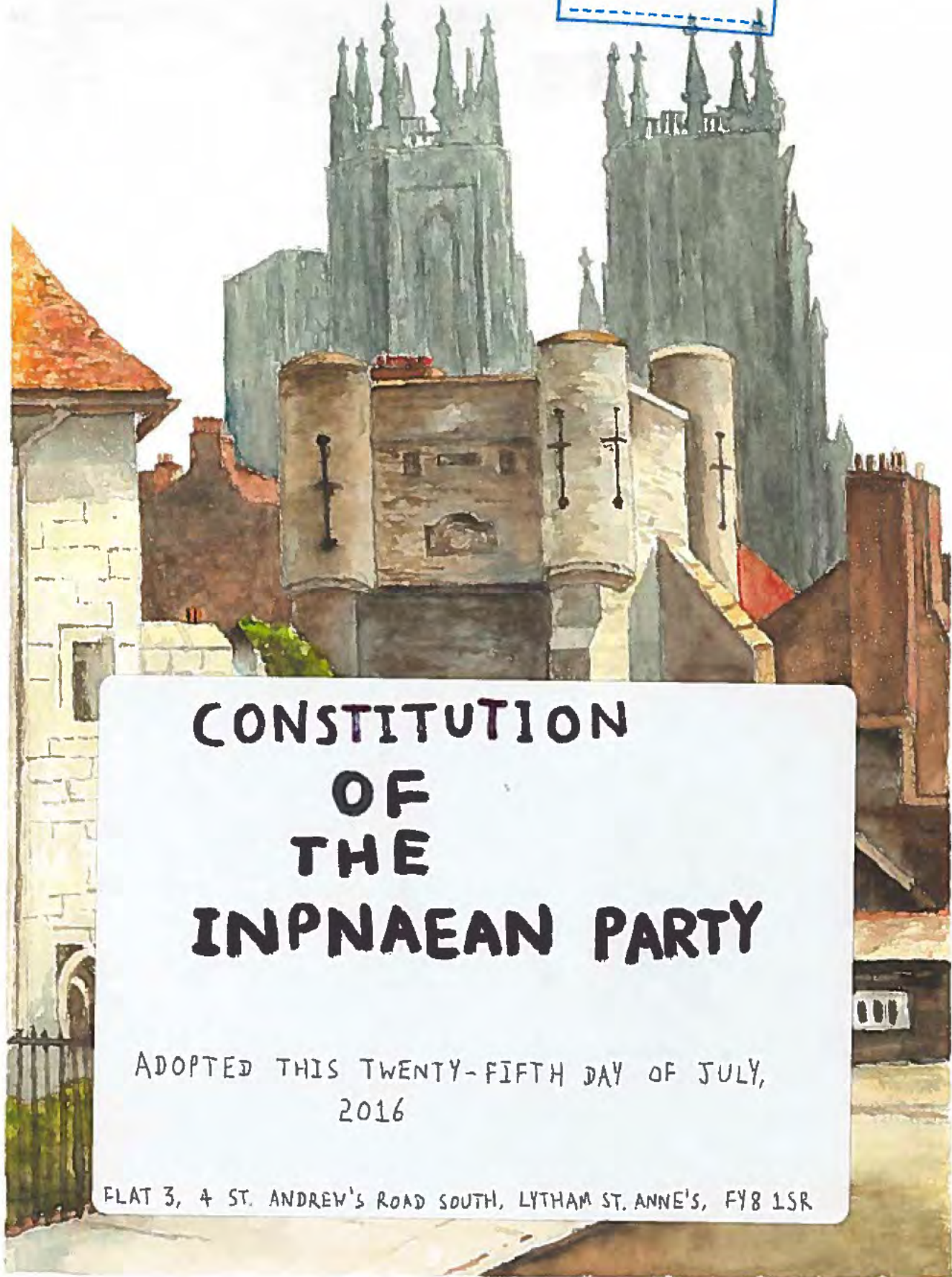

CONSTITUTION OF THE INPNAEAN PARTY

- 1.-THE NAME OF THE PARTY SHALL BE "INPNAEAN PARTY"
 - THE REGISTERED DESCRIPTIONS OF THE PARTY SHALL BE "IMPERIAL-NATIONAL PARTY FOR NEW EUROPE" (FROM WHICH THE PARTY NAME DERIVES), "PARTY OF JONATHAN ■ MARIUS-SHERIDAN", AND "INPNAEAN PARTY" FOLLOWED BY VARIOUS GEOGRAPHICAL DESIGNATIONS.
- 2.-THE AIMS OF THE PARTY SHALL BE AS FOLLOWS:
 - TO PROMOTE RATIONAL, SCIENTIFIC AND ATHEISTIC THOUGHT WITHIN SOCIETY, TO ABOLISH ALL RELIGIOUS PRIVILEGES, AND TO END THE RELIGIOUS INDOCTRINATION OF CHILDREN, REMOVING RELIGION COMPLETELY FROM ALL SCHOOLS.
 - TO PROMOTE THE UNITY OF THE BRITISH ISLES, TO SUPPORT ENGLISH AND LATIN AS THE ONLY OFFICIAL LANGUAGES THROUGHOUT THE BRITISH ISLES, TO SUPPORT GIVING THE BRITISH OVERSEAS TERRITORIES OF GIBRALTAR, THE FALKLAND ISLANDS, PITCAIRN ISLAND, AND SAINT HELENA, ASCENSION AND TRISTAN DA CUNHA THE OPTION OF BECOMING INTEGRATED PARTS OF THE UNITED KINGDOM WITH FULL REPRESENTATION IN PARLIAMENT,

AND TO PROMOTE THE MOVING OF THE CAPITAL OF THE UNITED KINGDOM FROM LONDON TO A LOCATION ON THE ISLE OF MAN.

- TO PROMOTE THE UNIFICATION OF EUROPE, SUPPORT BRITISH MEMBERSHIP OF THE EUROPEAN UNION AND THE EURO CURRENCY, AND SUPPORT THE FUTURE MEMBERSHIP OF SERBIA, MONTENEGRO, SWITZERLAND, THE FORMER YUGOSLAV REPUBLIC OF MACEDONIA, ICELAND, NORWAY, GREENLAND, THE FAROE ISLANDS, ANDORRA, MONACO, SAN MARINO, LIECHTENSTEIN, MOLDOVA, TRANSNISTRIA, BELARUS, THE UKRAINE, GEORGIA, ARMENIA, ABKHAZIA, THE NAGORNO-KARABAKH REPUBLIC, AND SOUTH OSSETIA IN THE EUROPEAN UNION.
- TO SUPPORT AS THE BRITISH FORM OF GOVERNMENT EITHER A REPUBLIC OR A WHOLLY NON-RELIGIOUS MONARCHY IN WHICH THE MONARCH'S SUCCESSOR IS NOMINATED.
- TO PROMOTE THE WORLDWIDE RECOGNITION OF EXISTING COUNTRIES AND BORDERS, INCLUDING THE TURKISH REPUBLIC OF NORTHERN CYPRUS, TRANSNISTRIA, THE NAGORNO-KARABAKH REPUBLIC, ABKHAZIA, SOUTH OSSETIA, MOROCCAN RULE IN WESTERN SAHARA, SPANISH POSSESSION OF CEUTA, MELILLA, AND OLIVENZA, AND BRITISH POSSESSION OF GIBRALTAR AND THE FALKLAND ISLANDS.
- TO END ALL GENITAL MUTILATION OF CHILDREN, ESPECIALLY MALE CIRCUMCISION, TO SUPPORT THAT IN ADULTS THIS BE TREATED AS ANY OTHER REQUEST FOR REMOVAL OF HEALTHY BODY PARTS WOULD BE, AND TO SUPPORT HARSH SENTENCES FOR THOSE GUILTY OF MUTILATING CHILDREN.
- TO SUPPORT THE PEACEFUL DEVELOPMENT OF ANTARCTICA FOR THE BENEFIT OF HUMANITY, AND SUPPORT NEGOTIATIONS BETWEEN BRITAIN, CHILE, AND ARGENTINA REGARDING ANTARCTIC BORDERS.
- TO SUPPORT THE RESOLUTION OF THE ISRAELI-PALESTINIAN ARAB CONFLICT ON THE BASIS OF TWO NON-RELIGIOUS STATES.
- TO PROMOTE SPECIAL TIES BETWEEN EUROPE, THE AMERICAS, AND JAPAN.
- TO OPPOSE MILITARY CONSCRIPTION EVERYWHERE, ESPECIALLY WHEN RESTRICTED TO MALES.
- TO SUPPORT SAME-SEX MARRIAGE, AND THE ENDING OF ALL RELIGIOUS INVOLVEMENT IN MARRIAGE.
- TO END ALL INEQUALITY BETWEEN THE SEXES, ESPECIALLY THE TREATMENT OF MALE LIVES AND BODIES AS LESS VALUABLE AND DIFFERENT TREATMENT OF VIOLENCE AGAINST MEN AND WOMEN.
- TO PROMOTE THE IDEOLOGICAL WORLDVIEW OF THE PARTY'S FOUNDER, JONATHAN [REDACTED] MARJUS-SHEAIDAN.

- TO SUPPORT THE PAYMENT OF BENEFITS BY THE STATE TO ALL WHERE REQUIRED TO ENABLE THEM TO HAVE AN ACCEPTABLE STANDARD OF LIVING, AND TO SUPPORT THE ABOLITION OF "SIGNING ON" AND SANCTIONS AT JOBCENTRE PLUS OFFICES.
3. IN ORDER TO ACHIEVE THE ABOVE AIMS THE PARTY SHALL SEEK TO STAND CANDIDATES AT PARISH/COMMUNITY COUNCIL, BOROUGH/COUNTY COUNCIL, NATIONAL ASSEMBLY FOR WALES, SCOTTISH PARLIAMENT, UK PARLIAMENT, AND EUROPEAN PARLIAMENT ELECTIONS IN ENGLAND, SCOTLAND, WALES, AND THE SOUTH WEST ENGLAND & GIBRALTAR COMBINED REGION. INITIALLY THE PARTY WILL FOCUS ON LANCASHIRE, MERSEYSIDE, AND CHESHIRE WEST & CHESTER. THE PARTY MAY RAISE MONEY, OPEN BANK AND/OR BUILDING SOCIETY ACCOUNTS, HOLD AND DISPOSE OF PROPERTY, SUPPORT OTHER GROUPS WITH SIMILAR AIMS, AND ENGAGE IN ANY OTHER LAWFUL ACTIVITY.
 4. PROSPECTIVE PARTY MEMBERS MAY APPLY IN WRITING TO THE PARTY LEADER IN ORDER TO REQUEST PARTY MEMBERSHIP. THE REQUEST WILL THEN BE ACCEPTED OR REFUSED. MEMBERS MAY BE EXPELLED FROM THE PARTY WHERE THERE IS GOOD REASON TO DO SO, AND THIS DECISION MAY BE APPEALED IN WRITING. MEMBERSHIP IN THE PARTY IS INCOMPATIBLE WITH MEMBERSHIP IN ANY OTHER POLITICAL PARTY OR ANY OTHER ORGANISATION WITH OPPOSING AIMS.
 5. MEETINGS OF PARTY MEMBERS WILL BE HELD PERIODICALLY, EITHER IN PERSON OR ELECTRONICALLY (E.G. SKYPE), AT WHICH VOTES WILL BE TAKEN ON RELEVANT MATTERS.
 6. THE PARTY SHALL HAVE A PARTY LEADER, NOMINATING OFFICER, TREASURER, AND ADDITIONAL OFFICER. THESE RÔLES NEED NOT BE FILLED BY MORE THAN TWO PEOPLE IN TOTAL. AT ESTABLISHMENT, THE PARTY LEADER, NOMINATING OFFICER, AND TREASURER WILL BE MR. JONATHAN [REDACTED] MARIUS-SHERIDAN, AND THE ADDITIONAL OFFICER WILL BE MRS. SYLVIA [REDACTED] ATKINSON.

7. THE PARTY SHALL BE REGISTERED IN GREAT BRITAIN, IN ENGLAND, WALES, SCOTLAND, AND THE COMBINED REGION WITH GIBRALTAR, WITH THE ELECTORAL COMMISSION.
8. ACCOUNTS, FORMS, AND REPORTS SHALL BE SUBMITTED TO THE ELECTORAL COMMISSION AS AND WHEN REQUIRED BY LAW.
9. FOR COMMUNICATION AND PROMOTIONAL PURPOSES THE PARTY SHALL MAINTAIN:
 - A SKYPE ACCOUNT, UNDER THE NAME [REDACTED]
 - A WEB SITE, AT [HTTPS://SITES.GOOGLE.COM/SITE/INPNAEANPARTY](https://sites.google.com/site/inpnaeanparty)
 - AN E-MAIL ADDRESS, [REDACTED]
 - A GUILD IN THE MMORPG GAME "THE ELDER SCROLLS ONLINE" (EU MEGASERVER), UNDER THE NAME [REDACTED], UNDER THE CONTROL OF THE CHARACTER [REDACTED]
10. THE PARTY'S EMBLEMS SHALL BE REGISTERED WITH THE ELECTORAL COMMISSION.
11. THE PARTY COLOURS SHALL BE RED, YELLOW, PURPLE, PINK AND GREEN.
12. THE PARTY MAY BE DISSOLVED WITH THE CONSENT OF THE PARTY OFFICERS AND MEMBERS.
13. DAY-TO-DAY DECISIONS SHALL BE TAKEN BY THE PARTY LEADER, IN CONSULTATION WITH THE OTHER PARTY OFFICERS WHERE APPROPRIATE.
