Accessibility: consultation on draft guidance for Returning Officers

We have today (5 September 2022) launched a [consultation on draft guidance for Returning Officers on assistance with voting for persons with disabilities](#).

The Elections Act includes provisions relating to assisting disabled people to vote, and introduces a duty on the Commission to provide guidance for Returning Officers (ROs) on the requirement to provide reasonable equipment to assist voters with disabilities in polling stations. These provisions apply to UK Parliamentary and Police and Crime Commissioner elections. ROs must have regard to the Commission's guidance.

The changes made by the Act have provided a timely opportunity to review our existing guidance to help ensure everyone can vote independently and confidently. There should be no barriers to voting for disabled people, and everyone should have the right to vote on their own and in secret.

During the development of the draft guidance, we have engaged with a range of civil society, charity and third-sector organisations from Wales and across the UK. These represent people with physical and learning disabilities, mental health conditions, and invisible disabilities. We asked them about the barriers disabled voters experience and possible solutions to make voting more accessible.

We also shared information, via DLUHC officials, with members of their Access to Elections working group, and discussed the changes introduced by the Act with representatives of the Society of Local Authority Chief Executives and Senior Managers (Solace) and members of the Elections, Registration and Referendums Working Group (ERRWG), which includes the Association of Electoral Administrators (AEA), electoral administrators and government officials.

Your feedback will inform the further development of the guidance in advance of our formal statutory consultation, which will start once the relevant legislative provisions have been commenced. We expect this to run from 28 November 2022 until 10 January 2023.

Electoral registration: accuracy and completeness study

The Electoral Commission periodically carries out a study of the accuracy and completeness of electoral registers. The [last study](#) was carried out on the December 2018 electoral registers.

This research involves cross-referencing a sample of register entries against the results of a large-scale, face-to-face survey of several thousand households across the UK.

In order to create the sample of register entries that we will use for the study, we will be asking a selection of EROs to provide us with a copy of the December 2022 revised electoral register for their area. We will be e-mailing those EROs in November to request a copy of their register.

The results of our accuracy and completeness studies identify those groups that are most likely to be under-registered, which helps to inform our public awareness activity and our guidance to EROs. We are grateful for your continuing support to enable us to carry out this important work.
