## Elections Act: guidance update

In line with our approach to supporting Returning Officers and Electoral Registration Officers with the implementation of the first phase of Elections Act changes, we have now published a second [key considerations guidance document](#) to inform preparations for the next phase of changes.

These include absent voting, overseas electors and EU citizens' franchise changes, as well as changes to postal vote handling and secrecy, commonly used names, and the offences of undue influence and intimidation.

This guidance is based on our current understanding of the UK Government's implementation plans. The detail of the secondary legislation is still to be confirmed, and so there are a number of areas where the guidance is based on our understanding of the policy or draft secondary legislation.

We will update the planning guidance as needed when the detail is confirmed, and will update you on any changes in future EA Bulletins.

We are continuing to develop our plans for the production and publication of the updated core guidance and resources you will need to support you with implementing the changes.

The draft regulations for the [changes to absent voting](#) have now been published and we are working on updating our guidance with the detail of that legislation. We aim to publish this guidance by early September ahead of the legislation coming into force on 31 October.

We will provide more details on the publication of updates to our guidance for the remaining provisions in a future Bulletin.
