You need to complete this form if your members' association has notified us that it made total political contributions of more than £37,270 in a calendar year. You will have done this by completing form UA1, which you can find on our website at <http://www.electoralcommission.org.uk/guidance/resources-for-those-we-regulate/organisations>.

You should complete this form for every quarter until your reporting responsibility lapses.

You must report to us at the end of every quarter after the contribution date, which is the day the political contributions exceed £37,270 in a calendar year, for the year in which you made the contribution and the next calendar year. Unless you make another political contribution your reporting responsibility will lapse at the end of the second calendar year.



Important: you should complete this form and return it to us within **30 days** of the end of the calendar quarter

You can use this form to tell us that:

- you have not received any gifts during a quarterly reporting period, or
- to confirm that you have already complied with your reporting responsibilities by reporting all the gifts you have received as donations and loans to your members' association

The calendar quarters are:

- Quarter 1 (January – March)
- Quarter 2 (April – June)
- Quarter 3 (July – September)
- Quarter 4 (October – December)

Completing and sending the form to us

You can type directly into the form and print it off to sign and send to us or you can print the form out, complete it by hand and send it to us.

Please do not submit this form electronically. The form needs a signature because it contains a declaration, so you can either **post** or **fax it to us**.

- UA1 'Notification of an unincorporated association making a political contribution'

You may also need to complete forms:

- RD1A 'Reporting a donation or a visit'
- RD1C 'Report of a controlled transaction by a regulated participant'

Section 1 – Details of the members' association

Please insert the full name and address of your organisation's main office and insert a reference number if we have already assigned one to you.

Section 2 – Statement of nil return or compliance

You must tick one of the boxes in this section. If you fail to tick either of the boxes in section 2 we will return the form to you as incomplete.

Section 3 – Declaration and signatures

The declaration must be signed and dated by the person named as the authorised individual for your organisation. You told us the name of this person when you notified us that you made the political contributions.



You will be making a declaration when you sign this form. You should be careful to ensure that you do not make a false declaration.

Definitions box

Members' association

An association comprising wholly or mainly of party members

Responsible person

The person authorised by the association to make a declaration on behalf of an association without a treasurer.

Gift

A gift includes anything given or transferred to any officer, member, trustee or agent of an unincorporated association in that person's capacity within the association. It includes:

- any donation to the association of money or property
- a bequest
- any subscription or other fee paid for affiliation to, or membership of the association
- any money spent in paying expenses incurred by the association
- the provision – other than on commercial terms – of any property, services or facilities for the use or benefit of the association (including the services of a person)

Political contribution

- a donation or a loan to a registered political party
- a donation to a registered non-party campaigner
- a donation to a registered referendum campaigner
- a donation to a registered recall petition campaigner
- a donation or loan to a regulated donee, which is:
 - a holder of elective office
 - a member of a political party
 - a group of party members (also known as a members association)

Donation

- any gift to the party or organisation of money or property
- any sponsorship provided in relation to the party or organisation
- any subscription or other fee paid for affiliation to, or membership of the party or organisation
- any money spent in paying expenses incurred directly or indirectly by the party or organisation
- the provision – other than on commercial terms – of any property, services or facilities for the use or benefit of the party (including the services of a person)

Holder of a relevant elective office

- a member of the House of Commons
- a member of the Scottish Parliament
- a member of the Senedd
- a member of the Northern Ireland Assembly
- a member of any local authority in any part of the UK, including the Common Council of the City of London but excluding a parish or community council
- a member of the Greater London Assembly
- Mayor of London
- another elected mayor
