You can register as a service voter or as an ordinary voter

The way you choose to register will depend on your personal circumstances. Your unit has a designated Unit Registration Officer who can give you more information. Ask your administration office for contact details.

Registering as a service voter

- **If you are in the armed forces or the spouse or registered civil partner of a member of the armed forces**, registering as a service voter allows you to be registered for five years at a fixed address in the UK even if you move around. You must renew your application every 5 years, but you can cancel it at any time. Registering as a service voter is particularly useful if you are based overseas or think you may be posted overseas in the next few years.
- **If you are under 18 and your parent or guardian is a member of the armed forces and you are living with them**, you can register as a service voter. You must be living in Wales or would be living in Wales if your parent or guardian were not based overseas. Your registration must be renewed each year and will end when you are 18 years of age. Then you will need to make a new application to register reflecting your circumstances at that time. You will be reminded to do so before your eighteenth birthday.

How to register as a service voter

- 1 Fill in this voter registration form.
- 2 Make sure you sign the declaration.
- 3 Return your completed form to us at the address shown above.
- 4 Problems with the form? Contact us if you need help understanding or completing this form – or if you need this form in large print or in another format.

Register to vote as soon as possible, or it may be too late to vote in the next election.

Voting at the polling station

At UK Parliament and Police and Crime Commissioner elections, you will need to show photo ID at your polling station to cast your vote. If you do not have accepted photo ID, you can apply for a free voter ID document, the Voter Authority Certificate. Your nationality and immigration status

Permission to enter or stay in the UK, Channel Islands or Isle of Man (also called Leave to Enter or Remain) refers to a legal immigration status.

We may need additional evidence about your nationality or we may check your nationality or immigration status against government records.

Section 3 'Your immigration status' determines your eligibility to vote in Police and Crime Commissioner elections only. It does not determine your eligibility to register to vote, or to vote in Senedd or local council elections in Wales. If this section applies to you, we may check your historical nationality or historical immigration status against government records.

Changed your name?

For example, you may have got married and changed your name. You do not have to give us details of your name change but it will help us identify you. If this information is not given, then you may need to provide additional documentary evidence.

Your date of birth

If you don't know your date of birth, please give the date you put on official documents (for example, your passport or driving licence) or tick one of the boxes. Your date of birth identifies you, confirms your eligibility to vote and can be used to call you for jury service.

The open register

There are two registers. Why? Using information received from the public, registration officers keep two registers – the electoral register and the open register (also known as the edited register).

The electoral register lists the names and addresses of everyone who is registered to vote in public elections. The register is used for electoral purposes, such as making sure only eligible people can vote. It is also used for other limited purposes specified in law, such as:

- detecting crime (e.g. fraud)
- calling people for jury service
- checking credit applications.

The open register is an extract of the electoral register, but is not used for elections. It can be bought by any person, company or organisation. For example, it is used by businesses and charities to confirm name and address details. If you are aged 16 or over, your name and address will be included in the open register unless you ask for them to be removed. Removing your details from the open register does not affect your right to vote.

If you are aged 14 or 15, you will not be included on the open register.

You will be included on the electoral register, but only Electoral Registration Officers and their staff can usually see the details you provide. Your details will not be included in any register that is published.

About six weeks before an election certain people need details of everyone who can vote in that election. If you will be 16 on the date of the Senedd or local council elections, your name and address will be given to people who run the elections, and to candidates who want to provide information to voters.

If you are concerned that having your name or address on the register may affect your safety, there could be other options available to you. In certain circumstances, you can register without your name and address showing on the register.

The Electoral Registration Officer is the Controller. Their lawful basis for collecting the personal information in this application form is that the processing is necessary in order to perform a task in the public interest as set out in the Representation of the People Act 1983 and related legislation.

The Electoral Registration Officer is legally required to process your personal information securely and comply with data protection legislation.

If you opted-out of the open register, your name and address can only be used for electoral purposes (including matching it against other data sources to support the electoral register) and other limited purposes specified in law. The law allows your information to be used for democratic engagement activities (by political parties, candidates, and agents), crime detection, jury summoning, and credit application identity checks.

If you did not opt-out of the open register your name and address can be bought by anyone and used for lots of purposes, including direct marketing.
