

Donations and loans received by political parties and non-party campaigners in the third pre-poll report at the General Election

Under the Political Parties Elections Referendums Act 2000, registered political parties must complete four weekly donation and loan reports prior to polling day on May 7 setting out what donations and loans they have received over £7,500 between 30 March (the start of the 'short' campaign) and 26 April. Two further reports follow after polling day for the period for the period 27 April to 7 May.

In addition, under the "Lobbying Act", registered non-party campaigners must also submit weekly donation reports setting out what donations they have received over £7,500. This information will be published alongside the political parties' donations and loans reports.

In this case, the party needs to confirm the name of the donor, company, or trade union and ensure the donation is from a permissible source within the 30 days from when it was received. The Party can return the donation at any point if they find that the donation is impermissible.
