You have requested:

Under the freedom of information act - can you please let me know how many people have contacted you to ask to change their vote regarding the referendum held on 23 June 2016. I only want statistical information, so no personal details. If this information is not available - can you please provide any similar statistics that you likely report regarding contact received following an election.

Our response is as follows:

I can confirm a small number of voters have approached to ask if they can change their vote after the referendum, to which we have confirmed in response that this is not legally possible. In total, 7 such queries have been received to date.

I trust that this information satisfies your request. The Commission strives to be an open, transparent authority
